Subject: Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) – Creation of MIS Portal.

A meeting of Group of Officers (GoO) was held under the chairmanship of Secretary (Coordination) on 07.10.2015 at 3:00 p.m. in the Conference Room, Cabinet Secretariat, Rashtrapati Bhawan, to consider the Note received from D/o Agriculture, Cooperation and Farmers Welfare (DAC&FW) vide their O.M. No. 19-5/2015-RFS-III dated 06.10.2015 on the above-mentioned subject.

2. Initiating the discussion, Secretary (Coordination) observed that an Integrated Web Based Portal on GIS platform is important for successful implementation of PMKSY. While Ministries have separate databases for their schemes, the specific components PMSKY need to be integrated to assist preparation of District Irrigation Plans (DIPs) under PMKSY and subsequent monitoring of their implementation.

3. Joint Secretary, D/o Land Resources (DoLR) informed that the Srishti-Bhuvan is an extensive database of the Watershed Development Projects with GIS tagging based on Bhuvan platform. The portal facilitates implementation, monitoring and effective planning of watershed management activities. Drishti is a mobile application for capturing field level information of activities and uploading on the portal. Further, MoUs have been signed with ISRO and NRSC in 10 States which form 60% of the total projects for monitoring and evaluating project through the portal.
4. Commissioner, M/o Water Resources, River Development and Ganga Rejuvenation (MoWR,RD&GR) informed that the WRIS portal contains all aspects of water resources and related data. The portal contains information in textual and image format besides spatial layer, of major and medium irrigation projects, Command Area Development works, headworks, waterways, basins etc.
5. It was brought out that MGNREGA also has an extensive MIS on the works being undertaken under the scheme at the village level. D/o Rural Development (DoRD) could consider geo-tagging the agricultural and related works which would facilitate planning at the village/household level.
6. Joint Secretary, DAC&FW informed that the website of PMKSY currently, with static features, has been operationalized from 13.08.2015. An MIS format has been developed which will source information from respective MIS of concerned Ministries/Departments for integration under PMKSY. Ministries/Departments concerned would need to make minor changes in their MIS to fulfil the requirement of integration in the integrated MIS for PMKSY. DAC&FW has circulated the format to MoWR,RD&GR as well as DoLR for their comments. It was observed that the MIS should be dynamic and serve as a planning tool to the districts for preparation of a DIP. The MIS should be layered with drill down details of various components/component of the Scheme. Integration with the GIS platform of Bhuvan should also be considered.
7. Representatives of NIC from DAC&FW informed that they intend to develop first an MIS for PMKSY based on 'as is' position from the existing databases of various components of different Ministries. The database will also have a facility for entering and updating data. This would be integrated later on with the GIS platform to serve as a tool for future planning in the districts. Meanwhile, they are also in the process of developing an MIS for the DAC&FW component of the PMKSY.
8. It was agreed that DAC&FW will constitute a team with representatives of their Department, DoLR, DoRD and MoWR,RD&GR. The team will also comprise representatives of NRSC as well as from NIC wing of each of these Ministries. The team will work in close coordination for developing an integrated MIS for PMKSY within two months. The Ministries provided details of the Members of the team which were noted.

9. After detailed deliberation, the GoO recommended that DAC&FW will constitute a Team with the following composition for developing an integrated MIS for PMKSY by 30th November, 2015. The JS (NRM&RFS), DAC&FW will closely monitor the progress and apprise the status on 31st October, 2015 and 15th November, 2015:
